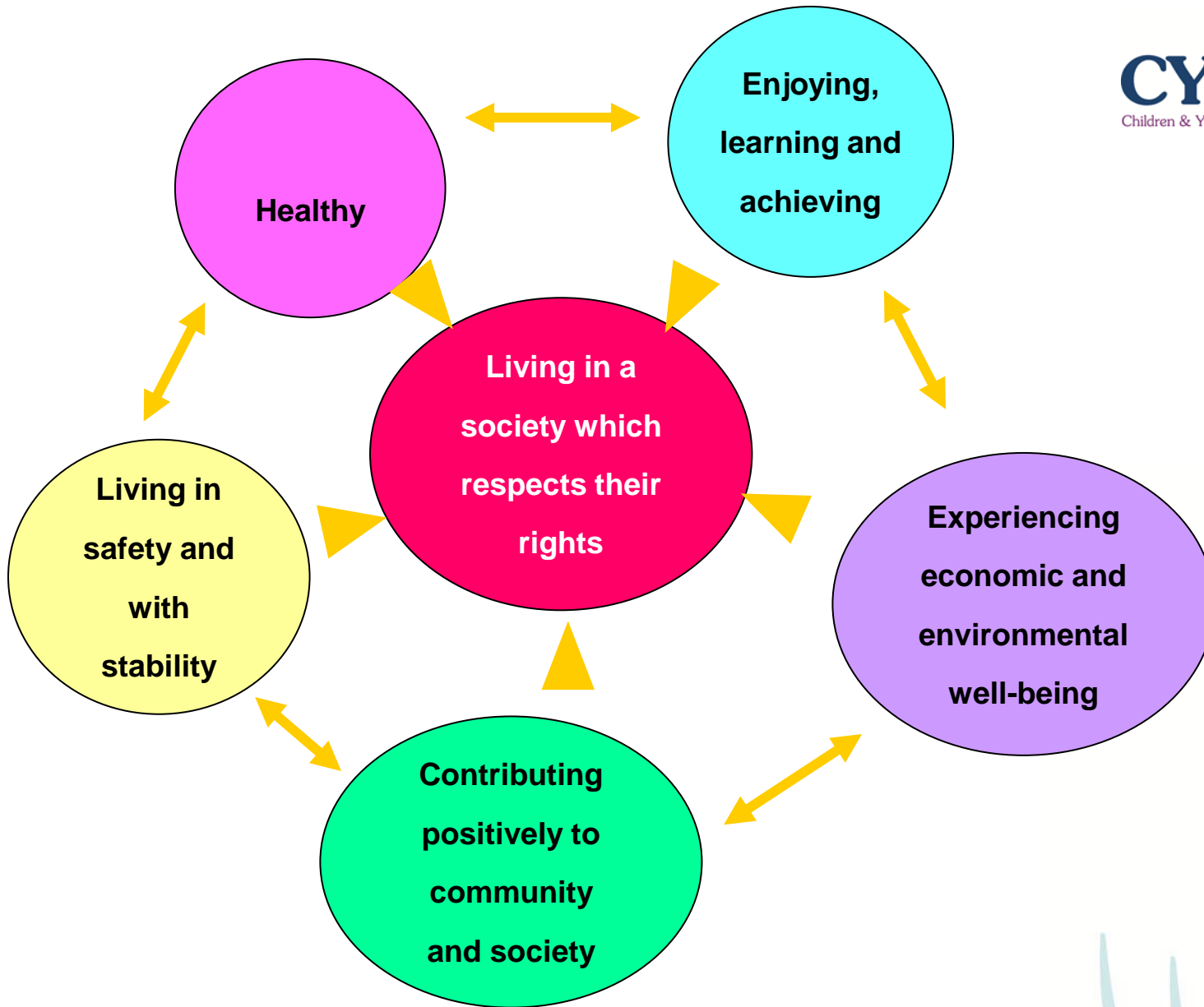

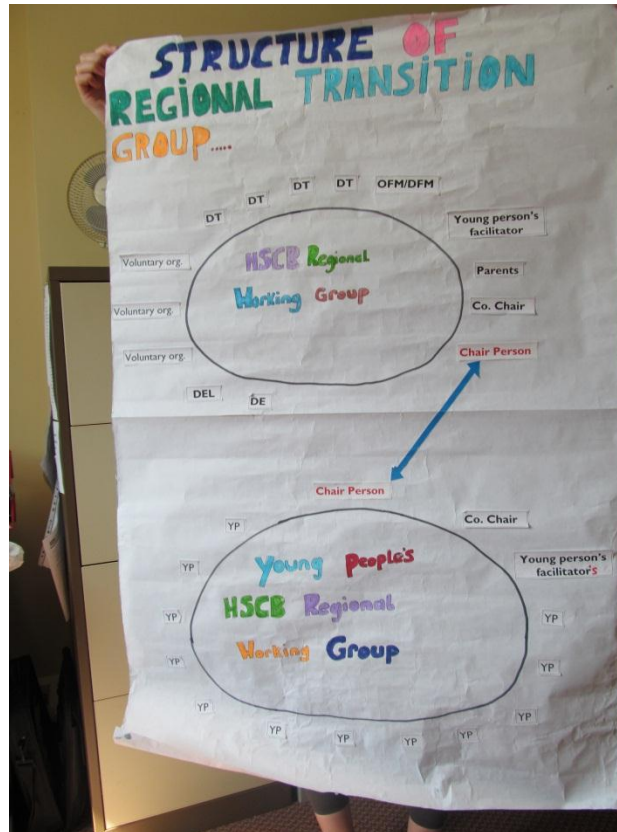


# Transitions Sub Group

# Specific Issues

1. **Person centered Planning!**
  - Person should be at the center of all decisions made about their lives
2. **Transition Services - Regional approach**
  - Everybody should get the same support at transition
3. **AHP Support beyond transition**
  - If YP feels they need it (pcp)
4. **Resources**
  - more day opportunities / work experience opportunities / choice
5. **Community Nursing Services**
  - Important for YP with complex needs
6. **Health and Wellbeing**
7. **Education**
  - Changing attitudes - Can do attitude
8. **Multi agency approach**
  - Right people coming together to help YP achieve their goal

# Relistic in 2 years

① Regional Approach

② Multi Agency Approach - <sup>education.</sup> "A can Do Attitude"

③ PCP with reviews

④ Professionals to have a more relaxed attitude when with yp <sup>flexible Person centred.</sup>

⑤ Citizenship training for yp (vol. sector) "Rights"  
(should be placed within Education sector/curriculum  
in the long term)

⑥ Ask the yps views + Listen to us! 😊

⑦ Be aware that all yp are <sup>not</sup> the same and promote this! 😊

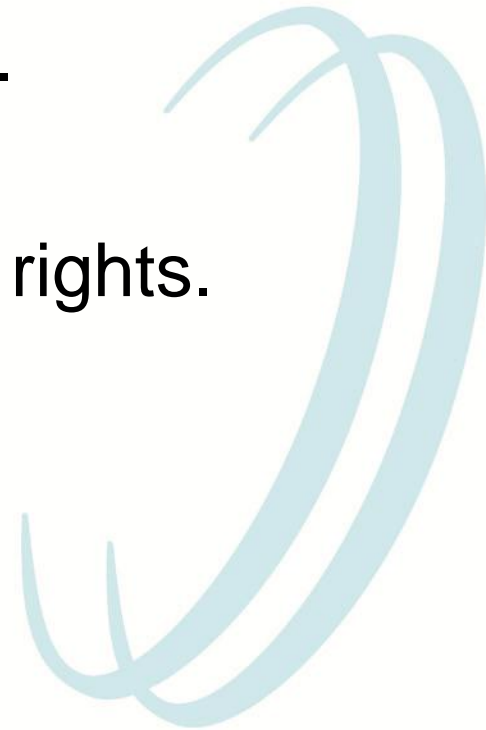
## (1) Healthy

- Develop an Integrated Plan for each person.
- Develop a Passport for each young person.



### **(3) Living in safety and with stability.**

- Promote awareness of disability in schools, youth clubs and local facilities in the community.
- Disability awareness training for staff.
- Ensure that young people know their rights.





## (4) Experiencing Economic and Environmental Wellbeing - Outcome

- One point of access for information available in accessible format.
- Review short break services.
- Review employment opportunities.
- Ensuring services are age appropriate and safe
- Ensure accessible transport and facilities for young people are available.

## **(5) Contributing positively to community and society.**

- Ensuring a person centred approach through self directed support including individualised budgets and direct payments.

# (6) Living in a society that respects their rights

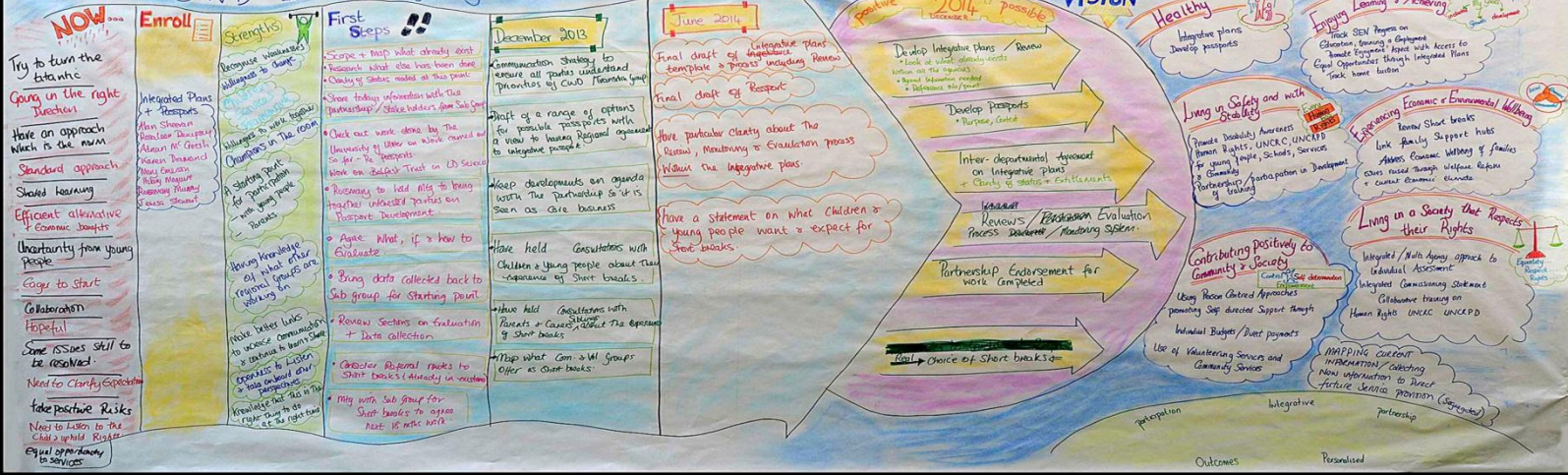
- Ensure that there is a Integrated/multi agency approach to individual assessment

# CWD and Transition journey ahead...



"One of the most innovative and exciting things about the engagement undertaken by the CYPSP Transitions and Children with Disability Sub Group is that the process of involving young people with disabilities in developing the plan started out with a blank page.

The young people didn't provide some input, they didn't give feedback on an existing plan - they were involved as co-creators of the plan from the outset.

They became leaders and drivers of key elements of the plan.

I haven't seen anything else across Europe to approach that depth of engagement in relation to regional planning around disability."
