Introduction

Franziska Hewitt and Maurice Leeson were welcomed to the group and there was a round of introductions for their benefit.

Previous Minutes

The note of the previous meeting on September 27th 2012 was approved.

Matters Arising

Remit of the Group

Deirdre Coyle was invited to revisit a previous discussion of the group regarding their remit with regards to Youth Homeless. Deirdre clarified that when a young person at 16 or 17 presents as homeless, social services have a duty to assess them and they become looked after children and therefore the remit of this group. Deirdre suggested that the focus of this group should also be on the prevention of presentations of homelessness. The group agreed that, in line with the principles of the CYPSP, the group will adopt a focus on early intervention and prevention. The group will maintain a strategic overview of youth homeless and also ensure that the prevention and early intervention of youth homelessness is on the agenda of other groups within the CYPSP.

Membership of Sub Group

The group noted that representation from the Youth Justice Agency had now been sought in Franziska Hewitt. There was an outstanding gap from the Education and Library Boards (ELBs). It was noted that their nomination process was more complex as one representative was sought for all 5 ELBs.

The Youth Justice Review Implementation Plan

Vivien raised the issue of how the group will link with proposed areas of work in the YJA Implementation Plan. Tony noted the existing Children, Young People and Offending Group who were already working with this Plan and the idea would be to link with them.
