### **Welcome and Introductions:**

Katrina welcomed everyone to the meeting and a round of introductions took place.

### **Apologies:**

Apologies were noted as above.

### **Minutes of the previous meeting held on 14<sup>th</sup> January.**

Alison Templeton highlighted that the main office of New Life Counselling is in Ardoyne, not Duncairn. Una will amend this accordingly in the minutes.

The remaining minutes were agreed as an accurate record of the meeting.

### **Matters Arising**

There were no matters arising.

### **Presentation - Karen Burns Geomapping of Gateway** (see attached presentation)

Karen explained the background to the mapping exercise that was carried out over a 6 month period looking at referrals to gateway and the referrals that did not meet the threshold for social services intervention. She highlighted that over a quarter of all the referrals came from North Belfast. She explained that many of the referrals that present into gateway have more than one issue, parental and young person's drug

and alcohol misuse, mental health of parents and child or young person were very prevalent as were behaviour issues. Karen explained that many of the referrals that were “assessed but not transferred” would be the types of issues that would be appropriate for a Family Support Hub at a Tier 2 level.

Discussions took place about issues of mental health and recognised diagnoses and also young people with unrecognised emotional issues who are taking drugs to cope.

**Action: Kevin Regan to give a presentation at a future meeting.**

A discussion followed about Family Support Hubs and the role that the Locality Planning Groups would have in identifying the number needed and the area covered by them. Members agreed that a more in-depth discussion needed to take place about the Family Support Hubs. It was agreed that a future meeting would be set aside to focus specifically on Family Support Hubs.

**Identifying Key Priorities for Action Planning in North Belfast**

As suggested at the January meeting Una had worked on a paper examining the 4 neighbourhood renewal partnership action plans in North Belfast. Una sifted through all the priorities in the NHR action plans relating specifically to children and young people into a single paper. She explained that there were a number of recurring themes. These are:

- Barriers to employment for parents/childcare/early years
- Parents/grandparents as role models/role of fathers/parental support/family tensions
- Sexual health
- Low educational attainment/support for parents and their children with homework/School & Community relationships/awareness raising of trades
- Perception of Young people
- Safety/community safety/good relations
- Mental Health

- Drugs & Alcohol
- Volunteering
- At risk/hard to reach/isolation
- Shared space/outdoor play
- Co-ordination of children & young people & family services
- Young carers
- Youth opportunities/youth forum/youth facilities/sports coaching/youth service provision/peer role models/community involvement/participation.

Members suggested that the action planning for the group needed some extra time and it was agreed that the meeting on the 11<sup>th</sup> March would take the form of a half day action planning workshop.

**Action: All members to attend action planning workshop. Una to circulate sift of NHR Action Plans, Statistics and Karen's presentation in advance.**

### **Any Other Business**

Glen Little explained that 10,000 Voices was a regional initiative that gives patients, as well as their families and carers, the opportunity to share their overall experience and highlight anything important, such as what they particularly liked or disliked about the experience in order to improve future services. Glen is trying to connect with as many people and groups as possible to collect their experiences. He asked members of the group who would have links with patients and carers who might like to talk to him about their experiences to contact him.
