

Outcomes Group Area Highlight Reports

What are these reports?

A report has been produced for each outcomes group providing the status/performance against the high level outcomes based on the **full population** of the outcomes area measured against a baseline of 2010, when the outcomes groups were established, providing the current status against the current NI average. These reports give a high level snapshot of how the full population of children and young people are doing across the whole of the Outcomes geographical area.

The report provides the most up to date available statistical value for each indicator identified in the ***indicators column** for the outcomes area as a total, with key LGD areas identified/flagged that may not be performing as well as they should. The ***status column** highlights, if at outcomes level, the indicators are either better or poorer than the ***NI average** and the ***trend column** shows the positive or negative direction the trend is moving in since 2010. An ***outcomes area baseline** value is also shown (***See relevant column on report**).

Note: These reports are a **supplement** to the full suite of information that is currently available on the CYPSP website.

What about small areas?

It is important that Outcomes Groups, Locality Planning Groups and their support workers continue to monitor the ward level/small area information for their locality groups (see attached small area **performance profile** or visit www.cypsp.org/maps-performance.htm) to identify those more local areas that are not doing as well as the full outcomes group geographical area and to prioritise those indicators and areas for intervention and highlight these back up to the outcomes group. Once interventions are put in place the results or outcomes of these will then be reflected in the overall population indicators being monitored in the highlight status/performance report at outcomes group geographical level.

Example of good practice:-

Downpatrick Sure Start identified issues from the CYPSP information relating to dental registrations for the Murlough Ward. Qualitative research was carried out to identify the number of dental surgeries accessible and available and thresholds in relation to registration of young children. This was cross referenced with information obtained from families who had not registered their children. Interventions were put in place during this current year to register all of those children identified. This will be reflected in the trend line and statistics for 2014 information and therefore in the South Eastern Outcomes Group Highlight Status/Performance Report.

What about areas of concern identified locally?

It is important that any qualitative issues raised locally should be tied in with the statistical information available where this is possible by checking what information is available locally that is directly relevant or by risk factor to allow for monitoring and measurement where possible.
