

- On 13 February, 2015, the Lord Mayor of Armagh hosted a civic reception to celebrate the "Achievements of Young People from the Barnardo's 6th Sense Advocacy Group in Partnership with Queen's University Belfast". At the reception, members of the 6th Sense Advocacy Group received certificates from QUB in recognition of their contribution to child and youth disability research at QUB.



- Professor Susan Parish from Lurie Institute of Disability Policy, Brandeis University, US visited the DRN in February 2015. Professor Parish presented a seminar on: 'The Social and Political Landscape of Family Caregiving for Children and Adults with Intellectual Disabilities in the United States'. The presentation examined some of the challenges of family caregiving in the US and discussed the pressing questions that face American policy makers and advocates such as: the needs of aging parent caregivers; the long-term consequences of chronic poverty and deprivation in these caregiving families; and the importance of resources in strengthening family support.
- The DRN was delighted to host Professor Michael Schwartz from Syracuse University, New York from January to June 2015. Michael was awarded a Fulbright

Scholarship to undertake research on access to healthcare for deaf people in Northern Ireland. Professor Schwartz, a deaf lawyer, is an associate professor and director of the Disability Rights Clinic, Syracuse law school's civil rights clinic for people with disabilities. Professor Schwartz gave a presentation on 1 June on 'Communication Access for Deaf people in the Healthcare Setting: An Insider's View from the Outside'

- In 10 June 2015, the DRN welcomed Kate Cameron, Lead Practitioner in Disability Services, South Australia. Kate presented a seminar on: 'When it seems too much: Supporting voluntarily placed looked after children and their families'.
- Dr Costanza Torri, University of New Brunswick, visited Queen's for the month of June 2015 to carry out research on the experiences of disabled women in Northern Ireland who are self-employed. Dr Torri met with 15 disabled women during her visit.
- Dr Audrey McKinlay (senior lecturer) will be visiting Queen's in September 2015 as part of a collaboration with Dr Mark Linden of the School of Nursing & Midwifery. Dr McKinlay, who holds positions at the Universities of Melbourne in Australia and Canterbury in New Zealand, will be delivering a workshop on the management of concussion in children and young people.
- Two special issues of Child Care in Practice on 'Valuing Disabled Children and Young People' have been published. The special issues were guest edited by Berni Kelly and Bronagh Byrne. The first special issue (Vol. 21(1)), published in January 2015 focused on childhood disability in the context of families, communities and service provision. The second special issue (Vol. 21(3)) published in July 2015 examines childhood disability in the context of participation, inclusion and social justice. - The International Paediatric Brain Injury Society (IPBIS) and the International Brain Injury Association (IBIA) will jointly hold the 1st International Conference on Paediatric Acquired Brain Injury on 16-18 September, 2015 at the Crowne Plaza Hotel in Liverpool, England. This will be the first global event that brings together all those involved in the identification, treatment and prevention of brain injury of children, adolescents, and young adults. The theme of the conference is *Supporting Young People and Their Families to Maximise Good Outcomes and Quality of Life.* The aim of the conference is to explore current and innovative treatments, rehabilitation programmes, support mechanisms, and ways to improve the lives and potential of these young people and their families (Contact: Dr Mark Linden).
