4. Presentation by Kelvin Doherty on LAC and YJS	<p>Kelvin Doherty, Assistant Director at the Youth Justice Agency gave a presentation on the Looked After Child Population and the challenges and issues facing them.</p> <p>One of the reason for the presentation, is that Ards and North Down has a higher than average representation of Looked After Children, with William St, James St, Marmion, Lakewood and Oakland's situated in the locality.</p>

	<p>The presentation was very well received and there were a number of questions and discussion following completion.</p>	
<p>5. Feedback from Family Fun Day 1st September 2017</p>	<p>JG/CP advised that there had been a better than expected level of attendance with a minimum of 500-600 people. Some feedback received was that people loved that everything was free, and there was a very upbeat and fun feel to the event. There had been some unexpected outcomes, such as a diagnosis of diabetes. Overall lots of support from all partners and the attendees seemed to get a lot from it. There was a good turnout from locals councilors, MPs, MLA's and even the mayor.</p> <p>There was some discussion of where the next event will be, with a view it should be along the Peninsula, in the new year.</p>	
<p>6. Keeping Safe Sub Group – Update and decisions</p>	<p>RP gave a brief overview of the group which had met on 11th Aug 17 and then handed over to ST, who referenced the summary document she had prepared and took the members through this.</p> <p>After some discussion, it was agreed that our LPG would be keen to attend a breakfast meeting hosted by SEDACT, to find out a bit more about services and to hear case studies/learning.</p> <p>The First responder scheme was discussed, and the group was keen to link into this. ASCERT have been awarded the contract to deliver this before end of March 2018. It was agreed that RP would make contact with ASCERT and find out more.</p> <p>It was agreed that LL will be this LPG's link with PCSP and that RP would approach PCSP Manager to see if the LPG could access any funding</p> <p>There was some discussion about the Targeted Life Skills programme, the TaTi (Talking about Tough issues) programme and</p>	<p>RP/ST to contact SEDACT to organise</p> <p>RP to speak to ACERT</p> <p>RP to contact PCSP re grants/funding</p>

	<p>the costs and benefits of each. It was agreed that the group would link in with Youth Justice to see if there are any opportunities to accessing funding to spread these further than current coverage.</p> <p>There was a general discussion on drugs ,with HK advising on the Rapid Bins initiative funded through the PCSP. He advised that the locality has got three of these, and that PSNI would empty this. Will officially launch this in Redburn.</p>	
7. Ards and North Down Directory of Services – Julie Bickerstaff	<p>JB advised that the Directory had been completed, with the official launch to take place on 11th October, between 12.00-2.00 in Ards Town Hall. Feedback has been very good. The group commended JB for her hard work in developing this.</p>	
8. Education sub group	<p>LL made the distinction that the group was not a sub group of this PLG, but would rather be a group that linked with the LPG and worked collaboratively to tackle common issues.</p> <p>LL advised that there were a goo range of partners including SERC, post primary/primary sector, AND council and local MP's. LL advised that next meeting of the group would be 15th Sept at which ST would be helping to run an OBA process to help identify priorities.</p>	
9. SIF Project update	<p>RP updated verbally, having been briefed by Mabel Scullion on the achievements for the SIF programme, which was continuing to perform well. There was still some concern about Incredible Years delivery, but this was hoping to be resolved with Early Years.</p> <p>RP then advised the meeting that was a small underspend in the SIF programme and set out the options for utilising this. Following discussion, it was agreed that any monies would be used 70% to pay for crèche to support delivery, 15% to support accreditation for IY and 15% to publicise the programmes.</p>
