4. Banbridge Action Plan	
Safe Places Training	
This is still on the agenda. Invitations open to organisations that may to host Safe place training. It is a 1.5	

hour free training awareness session. CYPSP could provide the Safe Places packs+ to any organisations



interested in availing of the training. Safe Place training is a signposting service for all organisations and buildings.

Lynsey put forward Gilford Community Centre to host and receive Safe Place Training. Contact name Alan Wilson Manager Tel: 028 38831708. Possibility of extending to other Community Centre's as Alan is manager for that area.

Colette put forward the Youth Resource Centre and the EA town Centre building to host and receive Safe Place training.

## 5. Emerging Needs and Member Agency Update

- Clanrye Rhiannon noted that drug use is becoming a big issue especially the usage of Lyrica (Pregablin). Usage of prescription drugs is becoming easily accessible and referrals are increasing on this issue.
- Gilford Youth Forum Lynsey has youth groups for 3 age groupings in Gilford, all of which are going from strength to strength. Peace IV coaches will be providing activities for young people at the community centre and youth leaders are coming on board.
- NIACRO Paul outlined the CAPS programme which targets 8-13 year olds at risk of offending. Currently
  a small waiting list and a range of participation including Traveller families.
  - EISS programme focusing on early intervention 12 week programme aimed at 0-18 year olds, referrals are through the Family Support Hub.
  - CHIP programme which provides support to children who have parent or sibling currently in prison in Northern Ireland.
- Peace IV Emma gave an overview of upcoming activities: Muga programme due to start in March, Unemployment programme for 16-24 year olds, DV8 Youth Diversion for 15-19 year olds, Midnight Soccer and Craigavon outdoor pursuit programme. Also, Health and Wellbeing programme for women in Gilford.
- Community Development Debbie outlined a number of awareness sessions which may be of use to groups: CST free training, Development Officer training on request, assistance with updating policies for groups and smoking cessation awareness. Community Planning events currently taking place across ABC council areas.
- CYPSP Action planning to begin in April 2018. Key priorities and actions to be identified for the next 3
  years by the group. Darren mentioned the Celebration of Locality Groups event which is due to take place.
  An invite will be circulated.
- EA Colette highlighted that the EA were currently reviewing the service and structures to run co-terminus with local government. The EA survey carried out in October 2017 highlighted a number of similar themes of physical health, mental health and bullying in the age groups 9-13 years and 14-24 years. The Gimme 5 programme Level 1 is recognised by the PHA. The EA learning together programme for years 13 and 14 is taking place and Peace IV workers currently being recruited. The EA supports the voluntary sector
