	Una led the members in the review of the standards exercise.						
	Una told the group that she would collate the scores and

	An issue that was raised in discussions was the challenge of						
	finding venues in the community to hold meetings or undertake						
	1:1 work or family group work.						
	ACTION: Priscilla is going to investigate the possibility of						
	undertaking a community audit of suitable venues.						
	Also raised was the lack of childcare space for families						
	undertaking parenting courses or attending training.						
	ACTION: Priscilla will raise this with the Outcomes Group & also						
	at the Childcare Partnership Meeting.						
5.	Update from Members						
	Michaela O'Kane offered an update to the launch of DICE 2 who works with young people (aged 10-21) affected by hidden harm (familial substance misuse). It offers individual work for them to help them come to terms with how hidden harm has affected them e.g. they may suffer anxiety, have poor coping strategies, low self-esteem, their own drug and alcohol issues etc. DICE 2 also offer group work as the research shows group work is positive for those affected by hidden harm as it gives them a degree of commonality and offers them respite amongst other things. Karen McHugh updated the members about the joint initiative						
	with CAMHS Team visiting GPs & their managers across the Trust and informing them what their role is and how to refer to either CAMHS or the Hubs.						
	DICE 2 offers workshops for Year 7 and 8 to raise awareness of the topic and help develop the young people's coping strategies						

	as well raise awareness of where to get help. It also offers training workshops for professionals to learn more about hidden harm. Research is telling us that at least one person from each organisation should be trained in how to deal with hidden harm.
6.	 AOB Priscilla highlighted: Western Domestic and Sexual Violence Partnership along with PCSP are holding an event in Tara Centre on Coercive Control 9/10/18. Also GP training is being provided at a GP study day which she is helping to facilitate. Spaces still available for Sharenting Awareness Raising facilitated by Debbie Greaves, WHSCT, on 05/11/18 Antipoverty Framework for Social Worker launch & accompanying paper on poverty in NI 29/10/18. Priscilla is presenting the findings from the 'How families are Experiencing Poverty' session organised by LPGs The Digital Safeguarding Group is providing two sessions of its new training covering aspects such as online gambling, sexting, bullying and gaming. The 16+ Forum facilitated by David Taylor, SUSE is offering training into Universal Credit in November. Make The Call has been approached to offer training for LPGs on PIP Hopefully Sean McCrory CAWT will be able to attend a future meeting to inform the members about the MACE development.
