

Northern Outcomes workshop 9.2.21

Welcome and apologies noted

- Purpose of today's workshop to develop CYP action plan 2021/2024 with respect to the Northern Trust Area.
- 4 high level areas to focus on.
- Noted Potential charities monies allocation overview from Hugh Nelson, additional funding stream available to help address MH and EWB. NHSCT charities together raised£457 m last year UK wide, 2 tranches of funding stage 2 to support partnerships across geographical areas that support communities affected by COVID-19 and stage 3 - Recovery grants to support recovery plans which could include: adjustments and resumption of normal services. MH and EWB work in community ongoing at present largely focusing on adults, this will be an opportunity to focus on children MH and EWB. Signification allocation £209k under partnerships and £247k for recovery. An outline grant proposal is required in the first instance in order to determine whether a full grant application will be acceptable to NHS Charities Together.

- Development of early interventions re ASD/ADHD across all age groups
- Enhance engagement with schools to provide support to those children who would be of significant concern but do not meet the threshold for CAMHS intervention
- Develop recovery supports for children and their families that have been significantly impacted on by COVID
- Task and finish group member to include reps from EA, PSNI, PHA and Voluntary/community organisations.

Room 2: Early intervention support for children with disabilities and their families.
