A Global Pandemic

- On 11th March 2020, the World Health Organisation declared Covid19 a Global Pandemic.
- On 19th March the first person in NI died from Covid.
- Midnight 23 March 1st "Stay at home" Order comes into effect. (Lockdown).
- Amongst those hardest hit financially in the first lockdown are vulnerable families on low income.
- Particularly the self-employed who were immediately left with no income.

"The Language has often felt Trite and Misleading"

- "The Disease is not a great leveller, the consequences of which everyone, rich or poor suffers the same. Those on the front line, bus drivers and shelf stackers, nurses and care home workers, hospital staff and shopkeepers are disproportionately the lower paid members of our workforce, they are more likely to catch the disease because they are more exposed"

Case Examples

- Family with 5 children-parent working in low paid job, other parent providing childcare-could not afford to pay for childcare therefore unable to work. Family do not have transport and are isolated living in rural area with limited resources Cost of living increase have impacted them daily-oil and food vouchers provided. T & T grant for uniform costs.
- Family recently where parent was sick and unable to work-in process of sorting benefits -provided oil and food voucher as well as providing toys for Xmas. Parents were very stressed and worried about the future with the rising cost of bills with 4 small children. Family have never had to seek support in the past and felt very embarrassed asking for help.

Case Example 16+


Emergency fund supported refugee young person. Due to increase in energy costs and costs of living, Young person struggled to meet her dietary/cultural needs.

Emergency fund enabled young person to access foods required for her diet (has celiac condition) and purchase Halal food/meats to meet her cultural needs.

Emergency Fund also provided support with energy costs; this reduced financial burden current placed on young person and contributed to healthy adequate diet.

What happened in the cold chamber?

Air temperature reduced from 21C to 10C for 30 mins





Our Crisis Fund

- By 19th March 2020 Action for Children had launched an Emergency appeal for funds to help Children and families.
- Three weeks later we approved our 1st application in Northern Ireland.
- Since then, our Crisis fund has supported 28,345 children and young people, spending £1,531,973.(31/10/22)
- Crisis fund applications are made by our staff working with families for up to £250 per application. Turnaround is usually same or one working day. Authorisation within NI Leadership team.
- We have spent almost £80,000 in the Western Trust area supporting families with small grants since the beginning of the pandemic.



Supporting our Staff

- Recognition that Social Care employees are also directly impacted by #CostofLivingcrisis.
- Action for Children announced in early 2022 that it will align pay rates for our lowest paid staff with that of the Living Wage Foundation and received its accreditation in Autumn 2022.
- our lowest hourly rate of pay increased from £8.91 per hour to £9.90 from 1st April 2022. This works out at an annual salary of £19,100 based on a 37-hour working week
