	1. Welcome and Introduction		
	Deirdre Walsh opened the meeting by welcoming those in attendance.		
	2. Previous Minutes of 7 th September 2022		
	The Minutes from the last meeting on 7 th September were agreed as a true and accurate reflection of the discussion and no amendments were required.		
	3. Winter Pressures – Information Sharing		
	The Early Intervention Support Team within the BHSCT met with the 10 Belfast Family Support Hubs to discuss the current challenges facing families. Topics covered included:		
	i) Information on available practical support ii) What is support/funding is expected to be available iii) Current Hub pressures iv) Gaps in services		
	v) Hub experiences on delivering practical support vi) How families can be best connected to resources.		
	Despite having no information about any financial support, the meeting was very helpful and productive.		
	The Belfast Harbour Commission have donated £1,000 to each Belfast Hub. It is understood the Hubs will have flexibility to spend this as they see fit, which will probably take the form of supermarket vouchers		
	A short discussion took place about Christmas toy donations. It was noted that there are fewer donations coming in this year and that every child deserves a new gift for Christmas. Vouchers are also a good choice, especially for teenagers who are often an overlooked group.		
	4. Members Updates		
	Piarais McCaffrey – Kids Together The GP Federation have funded Kids Together to create a course for children with Autism. The course is aimed at practitioners to discuss their concerns and expectations with the overall aim to have mainstream settings autism friendly and make staff aware of how they can achieve this.		
	The course is a 3 hour session and can be tailored to suit specific requests or groups. It is expected to have around 15 people per group.

Sharon Nelson - Whiterock Children's Centre

Parents are struggling to submit applications for school meals. One school stated they are having to cover around £500 per month to feed children as applications are taking a long time. The application process is not always straightforward and sometimes parents are not aware of the reasons why they were refused.

Alice McGlone - Belfast City Council

Community centres are open for people to keep warm this winter. A full list of 'Warm Hubs' will be circulated.

BCC have agreed to award grants of £500 and £200 for organisations who are currently in receipt of the revenue or capacity grants respectively. In order for these organisations to receive these grants they need to ensure their paperwork and returns are all up to date.

There was a motion to council in October regarding fuel poverty and as a result the BCC have agreed at £500,000 hardship fund. A meeting is to take place shortly regarding how this money should be best spent and administered so more information to follow, however it is likely to be after Christmas before the money is distributed.

An email has been circulated from the Education Authority stating that some children will be able to avail of free school meals even if they do not normally qualify. In order to benefit from this the child needs to be referred to EA by a 'key worker'. A copy of this email from EA will be circulated.

Alan Guthrie - GP MDT

Fr. Devlin of St. Paul's Parish is running a cost of living event on Thursday 24th November from 10am – 12.30pm. Lots of statutory and community colleagues will be involved in imparting advice and information about how to best manage during the cost of living crisis.

The GP Federation are keen to support groups in the community where there are gaps in services and gaps in provisions. There is some available funding to support families with ASD as described above with the Kids Together project.

The West Belfast Partnership Board are currently undertaking their resilience strategy. There is a consultation out at present for questionnaires and they are very keen to get people's views. The questionnaires can be completed online or via a hard copy.

5. LPG Update - Action Planning

The Sub-Group for the West Belfast LPG Action Plan met on the 5th October. It was agreed that there would be 4 priority areas:

- Children with Disabilities
- Emotional Health and Wellbeing

- Poverty Integrated Planning Discussions took place around what each of these topics looked like and what practical and realistic measures could be put in place to help alleviate some of these problems. However, this initial meeting was laying the foundations and further meetings will drill down into these topics and others in more detail until a fully functioning, working Action Plan emerges. The group hope to reconvene in January to examine in more detail and set goals.
