FSH Update	Ann-Marie (Barnardo's NI/FSH): FSH remains busy. Referrals for last year were 323, an increase of 15. Telephone enquiries increased from 59 to 116. Schools the biggest referrer to the Hub, followed by GP / Health Visiting. Autism Diagnostic Intervention Services will join the Hub starting this month. Education Welfare Service also attend bimonthly to provide a very useful link with education. The Hub would like to thank Health Visiting and School Nursing who have stepped up and taking a number of referrals and doing further assessments: this has been particularly useful, especially for self-referrals.

Group 1 Babies, Children & Young People

Catherine & Fiona (SHSHT), Adrian (EA), Karen (PSNI), Diane & Edel (ABC Council), Eleanor (Cruse), Raquel (Volunteer Now), Rebecca (BCM)

- Language barriers for accessing services and in schools
- Young people struggle to learn, behavioral issues, impact in the class and teachers
- Limiting staff delivering mental health and wellbeing programmes in school due to language barriers
- Barriers to volunteering, creating more opportunities to volunteer.
- Disengagement of young people and hesitant to commit to volunteering
- Impact of drugs and alcohol
- Online blackmailing and sextortion
- Looking for a safe space to go and socialize
- Impact of poverty and cost of living
- Young people attending youth centre in evening without a meal so programmes are around life skills and cooking
- Cruse is overwhelmed with referrals by both children and parents, as well as school requests. Still working with families bereaved with covid as it's still very raw for the families, specially covid enquiry and families looking for justice
- PSNI sextortion as young as 12, sexting, bullying online, vaping, mental health, neurodivergent children that might not have support, domestic violence, school unattendance due to anxiety and poor mental health, lack of resilience.

Group 2 Parents & Caregivers

Ann Marie (Barnardo's /FSH) Glenda (Foodbank), Mark (ABC Council), Mia (ArKe Sure Start), Paul (SHSCT), Joanne C (Armagh Rural Transport)

- Affordable housing suitable for families
- Relocation of the Food Bank proving very successful easier access increased footfall having more 'walk- ins' meaning self-referrals.
 Launching the social supermarket (more info available via Glenda)
- Increase in the complexities of referrals to the FSH the 'threshold' for safeguarding
- No therapeutic play available and no emotional support available for primary aged children
- Poverty continues to be an underlying element in the majority of family support needs

From ArKe Sure Start:

- length of waiting lists for children and families going through the assessment process and the lack of support with navigating this and subsequent diagnosis
- closures of a number of community playgroups within the southern area
- lack of counselling services for parents who are dealing with historic trauma which is impacting on their ability to parent their children.
